- 4. Bids must be delivered to the Palhinandan Rural Municipality, Kushma Nawalparasi (Bardaghat Susta Pashchim) on or before 12:00 hrs of March 14, 2018. Late bids will be rejected. Bids will be opened physically at 13:00 hrs of March 14, 2018 in the presence of the bidders' representatives who choose to attend at the Palhinandan Rural Municipality, Kushma Nawalparasi (Bardaghat Susta Pashchim).
- 5. All bids shall be accompanied by a valid bid security of an amount as shown in the table below in local currency or an equivalent amount in a freely convertible currency. The bid security guarantee shall confirm to the standard format as specified in the bid document. The bid security guarantee issued by only the commercial bank approved by Nepal Rastraya Bank shall be accepted by the employer.
- Bids shall be valid for a period of 90 days after the deadline for bid submission date. Bid security shall remain valid up to 120
 days after the deadline for bid submission.

In such case the validity of bid security shall be considered from already specified last date for bid submission.
