- Bidders may submit their bid electronically only to the Office of Executive Rural Municipality, Palhinandan Rural Municipality, Kushma, Nawalparasi through E-procurement section of PPMO's web site http://www.bolpatra.gov.np/egp as specified in the Instruction to Bidders on or before 12:00 noon 13th July 2018 (2075/03/29). Documents received after this deadline will not be accepted.
